

FLAME BBQ Street Festival 2024 Competition Terms and Conditions

General

- Information on how to enter and prizes form part of the Terms and Conditions.
- Entry into this competition deems acceptance of these Terms and Conditions.
- To the extent of any inconsistency between these Terms and Conditions and any other reference to this competition, these Terms and Conditions will prevail.

Who can enter

- Entry is open to all residents located within South-East Queensland over the age of 18, as of the date of entry, who have fulfilled the requirements set out below.
- Employees, and their immediate families, of the Promoter, Logan City Council and associated agencies and companies can enter the competition, but are not eligible to receive the prizes for this competition.
